



## Laminated Glass Warranty

Dear Client,

Subject to conditions and restrictions stated herein, each laminated glass unit is warranted for five (5) years from date of manufacture against manufacturing defects resulting in edge separation, delamination, deterioration of laminating film or obstruction of vision through the glass, and discoloration. Take note and be advised that no warranty will be extended against glass breakage, whether spontaneous, accidental or from any other cause.

This warranty shall be void if the architectural laminated glass is damaged during handling or installation or has not been installed in accordance with established/published glazing procedures such as those found in the latest versions of both the GANA Glazing Manual, and the GANA Laminated Glazing Reference Manual. These include but are not limited to the following:

- 1) Allowances in edge and surface bite relevant to the framing system and building movement caused by expansion and contraction.
- 2) Stress and strain as a result of localized application of heat, which causes uneven edge stress due to temperature differences in the glass.
- 3) Placement of any type of film (tint, reflective, or security) causing heat buildup in the lite resulting in uneven disbursement of heat, causing edge stress.
- 4) Installation in a system that does not include a weep system or some means of water repulsion.
- 5) Using non-compatible sealants, compounds, tapes, vinyl, paints or solvents. It is the glazing contractor's responsibility to insure material compatibility.
- 6) Laminated glass used in a butt joint or structural glazing system is not warranted.
- 7) Laminated glass used in a wet environment (shower, steam room, water feature, etc) is not warranted.
- 8) Post-laminating edgework is not recommended on laminated glass, therefore laminated glass with edgework (polishing or mitering) performed by anyone other than Brick Glass will not be warranted at all.
- 9) Post-laminated edgework (polishing or mitering) performed by anyone other than Brick Glass voids all manufacturers' warranties described herein.

Brick Glass reserves the right to field inspect any architectural glass alleged to be defective. Laminated Glass found to be defective will be replaced without charge, F.O.B. Houston Texas. The manufacturer is liable only for replacement of the material, not labor costs or incidental expenses or incidental or consequential damages.

Seller makes no claims to the buyer or any third party on the design of the laminated glass. Buyer assumes all responsibility for ensuring that the product is appropriate for intended application.

All of Brick Glass' laminated glass products must be installed within 30 days of delivery to ensure protection from moisture and warping.

This warranty shall not apply to any replacement glass past the original five (5) year warranty given on the initial unit or to glass used outside the continental United States. We make no warranty of merchantability, no warranty that the material is fit for any particular purpose or use and no other warranty, expressed or implied. Invoice must be fully paid according to terms or warranty is void.

We certify that laminated glass produced by **Brick Glass** conforms with both ANSI Z97.1-2004 and CPSC 16 CFR 1201 when labeled as such.
